

# ***PROGRESS REPORT OF DISTRICT DISABILITY REHABILITATION CENTER (DDRC) NAINITAL***

## ***PREFACE-***

*Govt. of India is presently operating different programs for different section of people around the country. As well known to every body that govt. i.e. Central as well as State is operating different kind of activities for the upliftment for every person in every sector of community and cast.*

*To ensure the enactment of PWD acts 1995(Equal Opportunities Protection of Right & Full Participation) Ministry of Social Justice and Empowerment, Govt. of India has taken many initiatives. Grameen Punarvas Yojna (GPY) is one of the important schemes to provide comprehensive rehabilitation service to the persons with disability at district level.*

*District Disability Rehabilitation Center (DDRC) Nainital, Uttarakhand was established under G.P.Y. Scheme of Ministry of Social Justice and Empowerment, Govt. of India to provide rehabilitation service to the persons with disability in Nainital District.*



*This center was inaugurated on dated 16<sup>th</sup> - Aug.-2009. For better achievement of DDRC a District Management Team (DMT) is organized by the District Administration under the Chairmanship of District Magistrate (DM), Nainital.*

*Since the formation of DDRC it has taken many welfare initiatives for Disabled Persons. The brief activities of DDRC done since the formation are incorporated with complete processing dates as below.*

### ***LOCATION OF DDRC, NAINITAL -***

*District Disability Rehabilitation Center (DDRC) Nainital, is situated at Sovan Singh Jeena, Base Hospital, Haldwani in the Nainital District of Uttarakhand State. The main cause of the establishment of DDRC at Base Hospital, Haldwani because it is the center place of Nainital District and situated at near the Roadways Station, at where Roadways buses go and come from all the blocks of District.*

***Starting to till 31st March 2010 with Date***

- *Seeing the situation of Handicapped Persons in Nainital District and in the direction of Commissioner, Handicapped, Uttarakhand, Implementing Agency, U.S.R. Indu samiti, sent a proposal to Secretary, Ministry of Social Justice and Empowerment, GOI, New Delhi through District Magistrate, Nainital on dated 18 August 2007 for regulating the District Disability Rehabilitation Center (DDRC) Nainital, Uttarakhand.*
- *On dated 23-Oct.-2007 the District Magistrate, Nainital sent the proposal of DDRC to Director, Social Welfare Department, Uttarakhand.*
- *The above proposal was sent to Secretary, Social Welfare, Uttarakhand by Director, Social Welfare Department, Uttarakhand on dated 03- July.-2008.*
- *The Secretary, Social Welfare Department, Uttarakhand sent this proposal to Secretary, Ministry of Social Justice and Empowerment, New Delhi on dated 22- July- 2008.*
- *The Implementing Agency sent the list of (DMT) District Management Team's members through District Magistrate, Nainital, to Secretary, Ministry of Social Justice and Empowerment, New Delhi. In the District Management Team (DMT) there were four officers named District Social Welfare Officer, Chief Medical Officer, District Panchayat Raj Officer and District Program Officer- Nainital had been selected for the better functioning of DDRC in the chairpersonship of District Magistrate, Nainital.*
- *In the direction of Secretary, Ministry of Social Justice and Empowerment, New Delhi, a letter had been sent to Chief Medical Officer, Nainital by*

- Implementing Agency to provide a rent free Building for regulating the DDRC Nainital In November 2008.*
- *In January 2009, in the direction of Secretary, Ministry of Social Justice and Empowerment, New Delhi, a joint account of Manager, Implementing Agency and Sub District Magistrate, Ramnagar had been opened for regulating the DDRC account after the recommendation of District Magistrate, Nainital.*
  - *All the above mentioned documents required by Ministry time to time had been sent to Secretary, Ministry of Social Justice and Empowerment, New Delhi through District Magistrate, Nainital after complete processing on dated 07-January- 2009.*
  - *The first installment of the DRS grant of Rs. 6,07000.00 to established the DDRC, Nainital had been sent in the account of USR Indu Samiti, DDRC, Nainital by Ministry of Social Justice and Empowerment, New Delhi on dated 06- Feb.-2009.*
  - *After the sanctioning of DRS grant from Ministry when Implementing Agency concern to Secretary, Social Welfare Department, Uttarakhand, she directed to Implementing Agency to not establish the DDRC in Government Hospital, Maldhan, Ramnagar due to not comfortable for district's Handicapped persons as well as ordered to District Administration for arrangement of building for DDRC in any Center Place of District.*
  - *The Pramukh Secretary, Uttarakhand Government directed to District Magistrate and Chief Medical Officer, Nainital to setup the DDRC at Base Hospital, Haldwani, Nainital on dated 25-Feb.-2009.*
  - *Seeing the above situation of building availability, Manager, Implementing Agency corresponded about this matter to all the District Management Teams' Members with Chairman; DDRC/ District Magistrate, Nainital on dated 02-Mar.-2009.*

- *When the Manager, Implementing Agency, concerned to Chief Medical Officer, Nainital about the matter of room availability for DDRC at Base Hospital, Haldwani according to Pramukh Secretary Letter. The CMO Nainital refused the argument of Implementing Agency saying such that there is no room available at Base Hospital, Haldwani and directed to Implementing Agency to contact the Superintendent, T.B. Hospital, Bhawali, Nainital for DDRC establishment.*
- *On dated 18-Mar.-2009, on the correspondence of Implementing Agency, the District Magistrate, Nainital sent a letter to Superintendent, T.B. Hospital, Bhanwali for taking the necessary action for room availability of DDRC at T.B. Sanatorium.*
- *A meeting was held of DMT Members in the chairpersonship of District Magistrate, Nainital on dated 21-Mar.-2009 at District Magistrate Office, Nainital after the argument of Implementing Agency. In this meeting, on the many points was discussed about DDRC establishment and other.*
- *After the recommendation of DMT, Implementing Agency sent a letter to Sub District Magistrate, Nainital on dated 21-Mar.-2009 to sing in letter for regulating the DDRC Account with Manager, Implementing Agency. After taken the sing of SDM sir, Implementing Agency fulfills all requirements of Bank and after it the Bank Account of DDRC was being regulated by Manager, Implementing Agency with SDM Nainital in the place of SDM, Ramnagar.*
- *After the recommendation of District Management Team's meeting, due to election period, the District Magistrate Sir, Nainital sent a letter to State Election Commission to purchase the equipments for DDRC's establishment on dated 23-Mar.-2010 according to Implementing Agency's correspondence dated 21-Mar.-2009.*
- *After the recommendation for room availability of DDRC of Superintendent, T.B. Sanatorium, Bhawali, Nainital. The District Magistrate, Nainital sent a*

*letter to Chief Director, Health and Family Welfare, Uttarakhand Government for permission to establish the DDRC at T.B. Sanatorium, Bhawali.*

- *On dated 30-Mar.-2009, the Secretary, Social Welfare Department, Uttarakhand sent a letter to District Magistrate, Nainital for taking action to establish the DDRC, Nainital at Base Hospital, Haldwani.*
- *On dated 13-Apr.-2009, the State Election Commission sent the permission letter for purchasing the Equipments of DDRC, Nainital.*
- *On dated 16-Apr.-2009, Chief Director, Health and Family Welfare, Uttarakhand Government sent a letter to CMO Nainital saying it that the Building which had been selected by District Administration at T.B. Sanitarium for DDRC Establishment would not be comfortable for the Handicapped Persons and ordered to above mentioned to take the necessary action for arrangement the building for establishment of DDRC, Nainital at Base Hospital, Haldwani.*
- *Seeing the pressure of Ministry and State Govt. for regulating the DDRC and sending the Utilization Certificate for second installment, Manager, Implementing Agency sent a letter, on dated 11-May-2009, to District Social Welfare Officer, Nainital for arrangement of two rooms for DDRC at Old ITI, Haldwani till the arrangement of rooms at Base Hospital.*
- *Former District Social Welfare Officer, Nainital promised to Implementing Agency to regulate the DDRC at old ITI till arrangement the building at Base Hospital.*
- *On the application of Implementing Agency for purchasing the Equipment for DDRC establishment, District Magistrate, Nainital called a meeting of all the District Management Team's members on dated 11-May-2009.*
- *Manager, Implementing Agency sent a letter to Secretary, Ministry of Social Justice and Empowerment, GOI, New Delhi for delaying the establishment of DDRC Nainital with progress of DDRC on dated 27-June-2009.*

- *After the design of DMT in Meeting and mainly in the direction of Treasurer District Nainital, an advertisement was published in Dainik Jagran Daily News Paper on Dated 30-June-2009 for sending the quotation by interested firms for Providing/ delivering the Equipment of DDRC.*
- *District Magistrate sir, Nainital now directed to Implementing Agency for regulating the DDRC Account jointly with SDM, Haldwani in the place of SDM, Nainital. In the direction of DM sir Implementing Agency fulfill the all requirement of Bank for changing such matter and now Account of DDRC, Nainital is being regulated by Manager, Implementing Agency and SDM, Haldwani jointly.*
- *After providing the rooms for DDRC at Base Hospital by District Administration, the DDRC had been started properly on dated 16-Aug.-2009.*
- *During the Sep.- 2009 Implementing Agency purchased all the Equipment for DDRC after Complete Processing of Purchasing with Tender Process.*
- *The Additional Secretary, Social Welfare, Uttarakhand and Commissioner, Handicapped, Uttarakhand inspected the DDRC on dated 25- Oct.-2009 and directed to Implementing Agency to take a written letter for providing the Rooms for DDRC.*





- *After the inspection of DDRC by Additional Secretary and Commissioner when Implementing Agency concern to CMS, Base Hospital about formal letter of rooms issuing, CMS sir gave a letter for issuing the rooms in Base Hospital for DDRC on dated 26- Oct.-2009.*
- *In the direction of Inspection report of Commissioner about issuing Rs. 5 Lac for DDRC establishment given by State Govt., Implementing Agency corresponded to District Magistrate/ Chairman DDRC Nainital to transfer the above mentioned amount of Rs. 5 Lac in DDRC' s account on dated 10 – Nov.- 2009.*
- *In Oct. and Nov. 2009, SDM sir Haldwani inspected the DDRC and ensured to Implementing Agency for taking any help for DDRC.*



- *For the better functioning of DDRC, Implementing Agency sent the two proposals to Secretary, Ministry of Social Justice and Empowerment, New Delhi through District Social Welfare Officer, Nainital on dated 30-12-2009, in which, one for second installment of DRS grant and second for ADIP grant.*
- *Seeing the lack of rooms for DDRC, Implementing Agency corresponded to District Administration and other relative officers but nobody taken any step on it despite of saying by Commissioner and Additional Secretary, Handicapped. Lastly Implementing Agency contacted to Minister, Health & Family Welfare,*



*Uttarakhand and Minister sir ordered to CMO, Nainital to take the action for it on dated 07-Jan.-2010 but, till today there is no action taken by relative officer.*

- *On the direction of Commissioner, in the last week of the month January 2010, Implementing Agency organized a Training Program of Aaganbadi Workers with the Chairpersonship of Chairman, Nagar, BJP Mr. Pradeep Bisht ji and other guest. In this training, 44 Aganvadi Workers of Haldwani region were trained for the identification of Handicapped children from 0 to 6<sup>th</sup> years by the DDRC worker Mr. Suresh Joshi and Mr. Dinesh Mathpal.*
- *After the complete certification and recommendation of District Magistrate Nainital and Director, Social Welfare Uttarakhand, the Secretary, Social Welfare, Uttarakahnd sent the both proposal of DRS and ADIP grant to Secretary, Ministry of Social Justice and Empowerment, New Delhi on dated 19-Jan.-2010 and 28-Jan.-2010.*
- *District Magistrate/ Chairman DDRC Nainital called a meeting of DMT to know the progress of DDRC on dated 06- Feb.-2010. In this meeting all District Management Teams' Members were present and Implementing Agency was directed to identify and survey of District's handicapped persons with Village Health Mission under Health Department.*
- *On the direction of above, Implementing Agency made a Performa for identification of Handicapped persons and two professional of DDRC, Mr. Dinesh Mathpal and Mr. Suresh Joshi, participated in each blocks' meeting of health mission, in which SDM, BDO, VDOs, ANMs, Asha Workers, Gram Pradhans and regional leaders were present. These meetings was held, as sequence, at Ramgarh on dated 11-Feb.-2010, Okhalkanda dated 15-Feb.-2010, Betalghat dated 16-Feb.-2010, Bhimtal dated 18-Feb.-2010, Ramnagar dated 22-Feb.-2010, Haldwani dated 23-Feb.-2010, and Dhari dated 25- Feb.-2010. Kotabag Block's meeting papers was distributed to Gram Pradhan through VDOs on dated 16-Mar.-2010 due to Election delaying. In these*

*meeting professionals, DDRC told to all the attended persons about the schemes of Social Welfare mainly for the Handicapped Persons and distributed the papers among Gram Pradhans with such request that these forms would be fulfill by Gram Pradhans or any representative and collect these in each block's BDO office through relative VDO. Now the result of above identification process is being shown and the progress of this survey has been sent to District Magistrate Nainital on dated 30- Mar.-2010.*

- *On dated 16- Mar.-2010, District Magistrate Nainital sent the cheque of Rs.5 Lac sanctioned for DDRC establishment and accommodation by Social Welfare Department Uttarakhand. The work is being done in the direction of SDM sir Haldwani.*

*Lastly, the progress of DDRC watched by all the officers and Leaders time to time and Implementing Agency is working yet according the direction of aforesaid.*

*Implementing Agency is working according to that Aim with the help and coordination of aforesaid, but Implementing Agency feels very bad due to not sanctioned the grant for ADIP in session 2009-10 by the Ministry, Social Justice and Empowerment despite of fulfill all requirement for ADIP Project and the Handicapped Persons, who was believed by the Implementing Agency to give the Equipments after receiving ADIP grant, has been got very sad.*

*During the session, the DDRC has been inspected by Respected officers, Leaders and Journalists etc. and all of these co-operated the Implementing Agency to improve the functional and financial activities for DDRC.*
